[November 5, 2018] On November 3, the Government of Japan announced the 135 foreign recipients of the 2018 Autumn Decoration, which is conferred by the Emperor of Japan.

• Order of the Rising Sun, Gold Rays with Rosette for Dr. Alexander P. Durtka, Jr., President, Japan-America Society of Wisconsin; President & CEO, International Institute of Wisconsin; Board Member, Wisconsin-Chiba, Inc.

Dr. Durtka has played a key role in fostering people-to-people Japan-Wisconsin exchange, particularly through the Wisconsin-Chiba sister state relationship. He has planned and facilitated events that highlight Japanese culture in Wisconsin. His dedication to the expansion of grassroots exchange between Japan and the U.S. has contributed to deeper understanding and has elevated Japan's presence in local communities.

• Order of the Rising Sun, Silver Rays for Mr. Larry Ingraham, Founder and President of Ingraham & Associates; Board Member, Japan-America Society of Indiana.
