Application Procedures for Multiple Visa for Nationals of Indonesia, Philippine and Vietnam

The following is an outline of application procedures for nationals of Indonesia, Philippines and Vietnam who wish to apply for a multiple-entry visa as a temporary visitor. The visa is for the purpose of tourism, business affairs, and to visits relatives/ acquaintances. It is not permitted to perform activities that undertake revenue generating business operations that result in receiving remuneration (payment) from an entity in Japan.

1. Applicant Eligibility

Nationals of Indonesia, Philippines and Vietnam are eligible to apply for this visa if they have an ordinary MRP (Machine Readable Passport) / e-passport in compliance with the ICAO (International Civil Aviation Organization) standard. This visa is valid for a stay of up to 90 days. You are eligible if **one** of the following situations is applicable to you:

- (A) You have a recorded history* of traveling to Japan under Temporary Visitor status in the last three years AND you have the financial capacity* to fund your trips.
- **(B)** You have a travel record* as a temporary visitor to Japan as well as to other G7 countries (excluding Japan) in the last three years.
- **(C)** You have sufficient financial capacity* to support yourself for the applicable time you may be in Japan.
- (D) You are a spouse or child of the individual who meets the criteria of (D) above.

^{*&}quot;Recorded history" and "travel records" will be evidenced in previously granted visas as well as arrival and exit stamps into the passport.

^{*&}quot;Sufficient Financial Capacity" will be judged by the visa officer reviewing your case. It will be judged on a case-by case-basis so please provide evidence of ALL assets to best prepare your application.

2A: Requirements for Application under Situation A:

You have a recorded history* of traveling to Japan under Temporary Visitor status in the last three years AND you have the financial capacity* to fund your trips.

VALID PASSPORT: Properly signed by bearer, must have at least two un-used blank visa pages.
COMPLETED VISA APPLICATION FORM: The applicant must complete the visa application form. You can fill out the form by wet ink pen or typing. Do not use pencil. Signature must be written by hand (no e-signature). On the application form, if there is a field not applicable, please write "N/A" or "None".
ONE PASSPORT SIZE PHOTOGRAPH: Please write your name on the backside of the photograph in print. Submit 2X2 inches or 2x1.4inches, color photo, taken in last 6 months. Use a clear image of your face. Do not use filters commonly used on social media. Have someone else take your photo. No selfies. Take off your eyeglasses for your photo. Use a white or off-white background without shadows, texture, or lines. Most of selfie and self-printed photos are rejected due to lack of quality.
YOUR BANK STATEMENT FOR THE PAST 3 MONTHS: This will be used to determine your financial capacity. Bank statement must be issued by your Bank in the U.S. <u>under your name</u> . If you have multiple bank accounts, please submit all of them.
