# JAPANESE BUSINESS FACILITIES IN 10 MIDWEST STATES: 2017 SURVEY

The Consulate-General of Japan in Chicago conducts an annual survey to determine the Japanese business presence in Illinois, Indiana, Iowa, Kansas, Minnesota, Missouri, Nebraska, North Dakota, South Dakota, and Wisconsin. The ten-state area is under the jurisdiction of the Consulate.

In 2017, a total of 1,411 Japanese business facilities were counted in the survey. Retail locations are excluded. Data is as of October 1, 2017.










